SOL, MAMLAC continue to serve community, students with legal education

Tarlac State University's School of Law **L** (SOL) continues its commitment to providing accessible and free legal services to the community through its Clinical Legal Education Program (CLEP).

Through CLEP, qualified law 2023. students under the Marc Andrei Marcos Legal Aid Center (MAMLAC), SOL's legal aid clinic, help clients as "law student practitioners" under the supervision of practicing lawyers.

As mandated by the Supreme Court under Revised Rule 138-A (Revised **Contributions to the indigenous** Law Student Practice Rule), CLEP serves as a required training for law students to enhance their learning opportunities and prepare them for law practice.

Free legal assistance

memorandum of agreement was inked between TSU and the City Government of Tarlac at the Kaisa Convention Hall, which assures the city's indigent residents of free legal advising through the Angel Care Program of Mayor Maria Cristina Angeles and SOL's CLEP.

This partnership materialized through the collaborative efforts of Mayor Angeles and SOL Dean Dr. Jose I. de la Rama Jr., both of whom were present during the MOA signing.

> This "Barangay Birth Registration" initiative is a recurring effort following a similar event last February, where approximately 100 Indigenous Peoples from the same barangay registered their births.

Forum on the West Philippine Sea

SOL organized a forum on the disputed West Philippine Sea at the Alumni Center in Lucinda campus last November 24, 2023.



Atty. Cecilio Dioneda Duka, the associate dean of University of Makati's School of Law, was invited as the lecturer of the forum titled "Awakening The Waves: Youth Awareness Summit on the West Philippine Sea Arbitral Ruling."

Atty. Duka tackled the nine-dash Said event saw 26 Aeta couples line, which claims that most of the disputed sea belongs to China. He also discussed China's aggression in taking over the West Philippine Sea, the harassment of Filipino fishermen, and the importance of the United Nations Convention on the Law of

the Sea (UNCLOS).

Daguio received a gold medal, trophy, and 60,000 pesos cash prize.

"This is my first time po to represent my beloved University. That is why this is one of the greatest achievements [I've] ever had, and (I am) grateful for it for having that. Until now, I'm still shocked po and 'di ko pa po ma-absorb lahat. It feels like ang bilis ng pangyayari," Daguio told OPA in an interview.

TSU returns to onsite QMS audit

its commitment to achieving excellence and continually enhancing institutional quality assurance, Tarlac State University once again passed the Surveillance Quality Management System (ISO 9001:2015) Audit conducted on November 16 and 17, 2023.

The two-day surveillance marks the auditor shared. the reimplementation of in-person audits after three years of virtual ISO audits due to the COVID-19 pandemic limitations.

Lead auditor Mr. Shahid Mushtaq from the ACS W3 Solutionz visited different university offices and some colleges according to the prepared audit plan and assessed their processes and system procedures in line with QMS standards.

In his presentation during the closing meeting, Mr. Mushtaq commended the strong management commitment of the university, as well as its dedication to the continuous improvement of its practices.

Moreover, he suggested several opportunities for improvement to

strengthen and "deepen" the university's QMS, which started in 2015.

the In response to recommendations given by Mr. Mushtaq, TSU President Arnold E. Velasco committed to complying with all the recommendations and suggestions that

"We uphold with all of us that we will continue with our processes [and] our practices that we do best. We also promise to improve or address our shortcomings... a review of the university's QMS We will continue the culture of quality and excellence in all performances through assessments and audits like this." Pres. department heads, as well as the review Velasco said.

During the opening meeting, Pres. Velasco highlighted the importance of the surveillance audit to ensure that the university's processes, systems, and practices meet and exceed the highest standards set by QMS focal persons.

"The surveillance audit is admirably a routine check in ensuring that our businesses here at TSU have in place our robust quality control procedures... The standards help locate and eliminate deficiencies, streamline operations, and encourage well-informed decisionmaking within the university to achieve better results and cost savings," Pres. Velasco said.

The audit process included practices, validated through the conduct of interviews and discussions with of documents that serves as evidence of Furthermore, he also expressed the university's delivered services and established systems.

messages and information dissemination to stakeholders.

His inputs were centered on elevating the university's quality of operations in terms of service, instruction, internationalization, and, most especially, the quality of its people.

"I know all of you are doing your best. Sometimes, what we really have to do is harmonize everything. And then commit and recommit; dedicate and rededicate; that we give our all, so that what we do here - the plans that we are putting together will be implemented because, at the end of the day, we will be measured by that," Regent Go said in his message to the administration.

"Before thinking outside the box, we need to think within the box. Consider our strengths, our pasts, the resources we have, and continuously improve them... I have high expectations for TSU, and those expectations, maybe, when we go back to the university, should be translated into positive action," he added.

Regent Go and Hon. Douglas C. Ferrer, representing the TSU Federated Faculty Union, proposed the creation of more focused and sustainable research and extension programs with a significant impact on the community.

In response, Pres. Velasco said that the administration works closely with the offices under the Vice President for Research Development and Extension to create more long-term programs and focus on impact assessment of extension projects to ensure relevance to communities to attain his vision for TSU to be recognized as a research institution.

Moreover, Pres. Velasco expressed confidence in TSU's future rankings,



commending the comprehensive plan and accomplishments of Roadmap D presented by the Office of Quality Assurance.

"I am optimistic [about] having another assessment, particularly the WURI (World University Rankings for Innovation), and with the things you presented now, I am starting not to worry," Pres. Velasco said.

istorically, November 30 is remembered Tas Andres Bonifacio Day, dating back to former president Elpidio Quirino's executive order. This year, however, President Ferdinand Marcos Jr. issued Proclamation 90, moving the Bonifacio Day commemoration to November 27, 2023, the nearest Monday to its original date. For the national government, switching the intended holiday date boosts local tourism. In the private sector, workers receive double pay if they report to their workplaces. But in the academe, the switching takes a toll on Monday classes, particularly at Tarlac State University.

President Marcos is not the first to implement the "moving of holidays." Holiday economics was introduced by former president Gloria Macapagal-Arroyo in 2007 under Republic Act No. 9492. Most holidays, including Bonifacio Day, could indeed be moved per the statute mentioned. The long weekends equate to Filipinos planning vacations within the country, which, in turn, promotes local tourism. Likewise, businesses thrive on these days. Aside from resorts and souvenir shops,

people flock to malls, restaurants, and cafes during holidays since they have the luxury of time. Consumer spending increases, and this helps the economy. All these paint a win-win situation. People rest, and the economy rises. Undeniably, there is wisdom in the holiday economics. Yet, in the academe, a different scenario arises.

At the collegiate level, sometimes at the high school level, some classes are only attended by students on a specific day. Case in point: A student has enrolled in a subject that is only available on a Monday. Because of holiday economics, the students and the a semester, they could miss at least four to five meetings, equivalent to missed opportunities. The holiday economics promotes long weekends; hence, Saturdays are affected, too. When people plan for vacations, of course, they will include the weekend. This adds up to the missed opportunities. Make-up classes will eventually be scheduled, but the learning momentum is already compromised. The question now is, did the national government consider the education sector in the holiday economics scheme?

Rest is good, both for students and faculty members. They get to go on vacations and unwind. But after the fun long weekend, they are welcomed by make-up classes. They might have even been dumped with activities during their long weekend because they could not physically attend classes due to the switched holiday dates. They spend their time with family and friends, but their minds might wander on the scheduled trips or bring their laptops to the beach because of deadlines. If professors and lecturers refrain from holding make-up classes, if they cram their lessons on the remaining Mondays, or assigned faculty meet on limited Mondays. In if they do not assign advanced reading or take-home tasks, learning is at risk.

> Aside from looking at holidays from the perspectives of tourism and economics, it is also wise for the national government to consider the academic calendar. It is only just for students and faculty members to enjoy holidays without thinking about their pending workload that compromises the quality of education. After all, the youth are the future drivers of the Philippine economy, and their education is a significant contributor to their and the country's future.



wo programs under the College of L Education (COEd) underwent an onsite evaluation by the Commission on Higher Education Regional Office III - Regional Quality Assessment Team (CHEDRO III RQAT) at the Lucinda Campus on November 30, 2023.

evaluation leads to the Certificate of Program Compliance (COPC) issuance for the programs Bachelor of Technology and Livelihood Education (BTLED) and Bachelor of Early Childhood Education (BECED).

During the exit conference, both programs earned positive feedback with minor recommendations from the team of evaluators.

Dr. Cecilia H. Teodoro, CHEDRO III RQAT member and BECED evaluator, commended the university's efforts and affirmed the program's compliance in all areas: administration, faculty, instructional facilities, laboratories and equipment, student assistance, and curriculum.

Likewise, BTLED evaluator Dr. Elmer B. De Leon noted that the university's TLE laboratories "tremendously possess (quality) beyond expected" and recommended the program for COPC issuance.

He also shared that he was impressed with the relationship and collaboration of the BTLED with the Technical Vocational Teacher Education

program.

Dr. De Leon said.

He also visited the laboratories of the College of Industrial Technology at the San Isidro Campus, which are shared with the COEd programs.

Both Dr. Teodoro and Dr. De Leon advised the college to continue purchasing updated library resources and increase library collection to be used by students and faculty members as reference materials for learning plans.

Moreover, head evaluator Dr. Anna Rodessa C. Calma, Education Supervisor II, commended the campus' facilities and waste management system.

On the other hand, Dr. Efren Abulencia, Education Supervisor II, sees a bright future for the COEd with a "very alive team spirit." He lauded the college's commitment to quality education.

the growing number of degree programs offered in COEd, we see TSU COEd in the future to be on deck, ready for Center of Excellence," Dr. Abulencia said.

In his message, TSU President Dr. Arnold E. Velasco thanked all the people behind the event and commended the programs offered by COEd to help more students choose from the many programs offered at the university.

"We should keep taking steps in this direction for our development as one of the most sustainable universities in the Philippines," Pres. Velasco added.

Likewise, Vice President for Academic Affairs Dr. Agnes M. Macaraeg also extended her gratitude to the evaluators, the Office of Quality Assurance, and the COEd faculty.

"We are really working at the VPAA that together, we can do more, and we can do things [extraordinarily]," VP Macaraeg said.

Official results for COPC issuance are expected to be released two weeks after complying with the evaluators' minor recommendations.
