APPROVED BUDGET FOR THE CONTRACT (ABC): ₱ 1,800,000.00

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply, Delivery, and Installation of Fourier Transform Infrared Spectrophotometer for the College of Science with an Approved Budget for the Contract (ABC) of ₱ 1,800,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on January 13, 2022;

WHEREAS, in response to the Invitation to Bid, five (5) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on January 21, 2022;

WHEREAS, in the public bidding held at the TSU-BC AVR and webcasted via Zoom on February 2, 2022, at 3:00 P.M.:

- (a) three (3) bidders, Instrumix Supplier, Inc., Chemisphere Lab Sciences, Inc. and ITS Science Phils, Inc., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bids of the three bidders and found the bids to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and were rated "passed",
- (c) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the three bidders.
- (d) the BAC resolved to declare ITS Science Phils, Inc. as the bidder with the Lowest Calculated Bid (LCB) with the bid price of ₱ 1,318,000.00, and
- (e) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the LCB.

WHEREAS, in the Post-Qualification Evaluation Conference held via Zoom on March 4, 2022:

(a) the TWG for Financial and Legal Aspect reported that the LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents.

- (b) the TWG for Technical Aspect reported that the LCB was non-responsive to the required technical specifications,
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB as non-responsive and post-disqualified,
- (d) the BAC directed the TWGs to proceed with the post-qualification evaluation of the bid of Instrumix Supplier, Inc., being the second Lowest Calculated Bid, and
- (e) the BAC directed the Secretariat to issue the Notice of Disqualification to ITS Science Phils, Inc.;

WHEREAS, in the Post-Qualification Evaluation Conference held via Zoom on April 5, 2022:

- (a) the TWG for the Financial and legal Aspects reported that the bid of Instrumix Supplier, Inc. was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the bid of Instrumix Supplier, Inc. was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the bid of Instrumix Supplier, Inc. responsive;

**THEREFORE,** We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- (d) to declare Instrumix Supplier, Inc., as the bidder with the Lowest Calculated and Responsive Bid for the project Supply, Delivery, and Installation of Fourier Transform Infrared Spectrophotometer for the College of Science with the bid price of ₱ 1,370,000.00 and
- (e) to recommend to the President the Award of Contract for the project Supply, Delivery, and Installation of Fourier Transform Infrared Spectrophotometer for the College of Science to Instrumix Supplier, Inc.
