APPROVING THE GENERAL APPROPRIATIONS ACT BUDGET PROPOSAL FOR FISCAL YEAR 2027 OF TARLAC STATE UNIVERSITY, WITH A TOTAL PROPOSED AMOUNT OF ₱1,286,165,000.00.

THE PROPOSED BUDGET HAS BEEN PREPARED IN ACCORDANCE WITH NATIONAL BUDGET MEMORANDUM NO. 156 (NATIONAL BUDGET CALL FOR FY 2027) AND NATIONAL BUDGET MEMORANDUM NO. 157 (BUDGET PRIORITIES FRAMEWORK FOR TIER 2). THIS PROPOSAL IS ANCHORED IN THE NATIONAL GOVERNMENT'S COMMITMENT TO ACHIEVING THE PDP 2023-2028 AND THE 2030 AGENDA FOR SUSTAINABLE DEVELOPMENT.
