The Civil Service Commission celebrates its 119th anniversary this September themed "Civil Service at 119: Upholding Integrity and Building a High-Trust Society." This is a commemoration of the enactment of Public Law No. 5, "An Act for the Establishment and Maintenance of an Efficient and Honest Civil Service in the Philippine Islands" on 19 September 1900.

Integrity, transparency, and honesty are some of the must-have values in government service. These must be inculcated and strengthened until it becomes part of an organizational culture.

Government instrumentalities are mandated by the CSC to include the "Panunumpang Kawaning Gobyerno" in their flag raising ceremonies as stated in CSC Memorandum Circular no. 02, s. 1995. This move by the CSC aims to institutionalize behavioral reforms in the bureaucracy with the end view of enhancing the delivery of public service for clients' utmost

Every Tuesday at 6:45 AM, TSU does the same. The Panunumpa ng Kawani ng Tarlac State University is recited wholeheartedly to remind the civil servants of the institution to serve with love, integrity, and values.

Last September 19, 2019, a seminar on employee branding or Tatak TSUian was held to reinforce the quality of public service TSU must provide to its stakeholders. The seminar reminded the TSU community that we are branded on what we do as civil servants.

Other than the CSC, public servants are also bound by Republic Act No. 6713 or the Code of Conduct and Ethical Standards for Public Officials and Employees. This statute sets the norms of conduct of public officials and employees in terms of personal conduct in the discharge and execution of official duties.

We are a reflection of the institution we belong to. What we do as civil servants bounces back to how stakeholders perceive TSU. Creating an image for the university is a collective effort. Hence, it is important to integrate the university's core values into every office work and transaction.

## **TSU launches Firefox Radio**



Tarlac State University formally opened its radio station, 87.5 Firefox Radio, through a launching program on September 10, 2019 at the College of Arts and Social Sciences Mini Theatre Room, Smith Hall.

Firefox Radio is the first campus radio established in the Tarlac Province. During the program, Dr. Aloysius T. Madriaga, CASS Dean, expressed his pride and happiness in this milestone of the college and the university.

"Sobrang masaya kami. It's a dream for the university. Let's patronize our own, let's listen to 87.5 Firefox Radio,' said Dr. Madriaga.

The said radio station is under the supervision of the CASS-Communication Department with Ms. Janice De La Cruz, program chairperson, as station manager and is operated by Prof. Winifredo Luis and Mr. Michael John Hipolito, faculty members dubbed as in-house radio jockeys.

Prof. Luis or RJ Louis B is on air every Tuesdays and Thursdays, 10:00-11:00 AM while Mr. Hipolito or RJ Mhack is heard every Wednesdays and Fridays, 10:00-11:00 AM.

Aside from the in-house RJs. Firefox Radio also chose six student radio jockeys through auditions spearheaded by the Communication Department. The student RJs are Shada Mashael Manuntag from the College of Business and Accountancy, Carlson Dave Pelayo from the College of Engineering and Technology, Jericho Miguelle Valencia and Mariko Campos from the College of Teacher Education, and Bealyssa Bianca Basto and Reignchill Kraiz Bactad from the College of Arts and Social Sciences. They will be on air from Tuesday to Friday, 8:30 AM to 5:15 PM.

The official airtime of Firefox Radio is from Tuesday to Friday starting at 7:00 AM to 6:00 PM. Its segments include daily morning English news, afternoon Tagalog news, radio drama, public service announcements, TSU President's Hour, and academic, administration and finance, and research and extension time slots.

The envisioning and planning of the Firefox Radio started with Dr. Agnes M. Macaraeg, former dean of CASS. It was initially planned as a laboratory for radio production classes, but now it will also cater to the entire TSU community.

# CCS team gets second place in HackforGov





The Tarlac State University College of Computer Studies-Cybersquad (TSU-CCS Cybersquad) placed second in the HackforGov: Computer Emergency Response Team (CERT-PH) Cyber Challenge in Robbinsdale Hotel, Manila last August 9,

Among the nine contenders from different Philippine cities and provinces who vied for the championship, TSU-CCS Cybersquad scored 1271 points which led them to the second place. Contestants were tasked to solve 30 problems in a given five-hour period.

The four CCS students of the said team are Carl Joshua Biag, Francis Miguel Herlaban, Nomar Lapitan, and Ryan Santillan with Mr. Carlos Flores Jr. as their coach.

Regarding preparation, Flores said they kept on sending each other some readings they needed for the competition.

HackforGov is the first-ever governmentinitiated capture-the-flag competition that requires competitors to solve a series of tasks like basic to advanced programming and hacking a server to steal data. The contestants need to find a specific piece of text hidden on

the server or behind the webpage.

The competition hosted by the Department of Information and Communications Technology (DICT) is an initiative to raise the level of awareness of students on the importance of cybersecurity and immerse them on techniques used in the cyberspace.

It will benefit and aid the Philippines in digital security measures and network penetration. The skills of the contenders can be used by the government to retrieve information and for investigations.

# **Ease of Doing Business to be implemented in TSU**



Tarlac State University implements Republic Act No. 11032 or the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018" through TSU Memorandum Circular No. 11, s. 2019, dated August 16, 2019.

RA 11032 aims to streamline the current systems and procedures of government services. This is a product of the joint efforts of the Anti-Red Tape Authority (ARTA), Civil Service Commission (CSC), and the Department of Trade and Industry where this law effectively amends RA 9485 or the Anti-Red Tape Act of 2007.

This is the landmark law of the Duterte administration that addresses priority no. 3 of the 0+10 Point Socio-economic Agenda to improve competitiveness and ease of doing business in the Philippines, according to the website of ARTA.

TSU will conform to the rules and regulations of the said act especially the receipt

- number of signatories to three for shorter and review their respective procedures processing
- Rule IV Section 1: limiting the processing time for a) simple transactions to 3 days; b) complex transactions to 7 days; and c) highly technical transactions to 20 days including activities which pose danger to public health and safety and public morals or publicity



- The Human Resource and Development Rule V Section 1: implementing the "zero-Management Office and the Office of Public contact policy" that prefers the electronic Affairs and Information facilitated a seminar submission of applications, requests and/or
- Rule VII Section 2: stating the liability applicability to the university with Prof. of receiving officers and requiring them to 1) inform of any deficiencies, 2) assign an identification number for the application/ request, and 3) give an acknowledgement

The resource speakers enjoined the Rule III Section 2(d): reducing the different offices in the university to revisit and charters and their compliance with the discussed law.

The national passing rate for ME board exam is 70.65% and 59.54% for the RME board exam.

# Fire and earthquake drill conducted in TSU















The Tarlac State University in cooperation with the Bureau of Fire Protection: Tarlac City Fire Station conducted an unannounced earthquake and fire drill last September 27, 2019 at the San Isidro Extension Campus.

The activity was led by the campus head. Engr. Marlon V. Gamido, and assistant heads Prof. Arnel Punla and Ar. Garry Advento. Also present in the event is the Office of the Vice President for Planning and Quality Assurance.

BFP Officers FO1 Louie Mercado, FO2 Marlon Castro, and FO3

Michael Angelo Castro supervised the drill in the College of Engineering and Technology, College of Architecture and Fine Arts, and College of Computer Studies respectively.

The simulation started with sirens blaring at 9:40 A.M. followed by fire alarms. Students is 6 minutes. were instructed to duck, cover, and hold. Those inside the classrooms briskly filed out afterwards with hands over their heads and proceeded to the designated evacuation areas.

Emergency response teams (ERT) were deployed in all buildings of the campus. After

which, one team emerged with a "casualty" that was promptly aided by the medic team.

A post evaluation was held where commendations were given to the execution of evacuation and the medic team. Areas of improvement were also addressed such as student accountability and search and rescue.

"Yun po yung structure natin- yung ERT. Yun po yung sinusunod natin. May communication team, may rescue, may firefighting. Yun po ang sinusunod nating protocol. Kahit na anong incident po 'yan, mapa-lindol, mapa-sunog, mapa-bagyo. Magdi-depende na lang 'yon sa emergency," FO2 Castro said.

The overall evacuation time totaled 8 minutes, while the standard time for evacuation

"Yung overall, nung tinanong ko kay Sir [Engr. Gamido], hindi pa naki-clear si Technology [kaya] medyo humaba pa ng kaunti. So sa communication, mai-improve pa natin 'yan," FO2 Castro added.

admittedly said in an interview, "Ang nakikita kong mas malaking improvement na nangangailangan is the communication. Kasi wala tayong communication facilities, like radyo na pwedeng magamit during emergencies. Yung mga gwardya, although meron silang radyo, siyempre nasa kanila 'yun. So, I think the safety officer and the unit under them must procure yung mga communication facilities."

Dr. Lolita V. Sicat, Vice President for Planning and Quality Assurance, noticed the lack of urgency among the students and emphasized the importance of being prepared.

"Dito ko nakikita yung essence ng ating practice na kailangan talagang seryosohin; because we do not know when disaster will come. So sama na po natin 'yan pag start ng klase natin- beginning of class, day one. How to exit from the buildings in case of fire, para walang nagpa-panic. Fall in line, carefully but very fast [as] you exit the room. Direksyon, kayo na po magbigay," she said during her In response to this, Engr. Gamido closing remarks. [Jodie Andrea G. Pangilinan]
