# BAC RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING THE AWARD OF CONTRACT

APPROVED BUDGET FOR THE CONTRACT (ABC): ₱ 1,371,839.00

WHEREAS, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Books with an Approved Budget for the Contract (ABC) of 7 1,371,839.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on September 16, 2022;

WHEREAS, in response to the Invitation to Bid, only one (1) prospective bidder participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via zoom on September 30,

WHEREAS, in the public bidding held at the TSU-BC AVR on October 7, 2022, at 2:00 P.M.:

- (a) one bidder, namely, New Century Books and General Merchandise tendered a bid for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bid of the lone bidder and found it to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and was rated "passed".
- (c) the BAC resolved to declare New Century Books and General Merchandise as the bidder with the Single Calculated Bid (SCB) for Lot No. 2 with the bid price of ₱ 1,075,651.95,
- (d) the BAC resolved to declare a failure of bidding for Lot No. 1,
- (e) the BAC directed the TWGs to proceed with the Post-Qualification Evaluation of the SCB for Lot No. 2, and
- (f) the BAC resolved to recommend to the President the procurement of Lot No. 2 using the appropriate alternative mode of procurement;

WHEREAS, in the Post-Qualification Evaluation Conference held via Zoom on December 1, 2022:

(a) the TWG for Financial and Legal Aspects reported that the Single Calculated Bid was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,

- (b) the TWG for Technical Aspect reported that the Single Calculated Bid was responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to adopt the reports of the TWGs finding the Single Calculated Bid as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) to declare the bid of New Century Books and General Merchandise for Lot No. 2 of the project Supply and Delivery of Books as the Single Calculated and Responsive Bid (SCRB) with the bid price of ₱ 1,075,651.95 and
- b) to recommend to the President the award of the contract for Lot No. 2 of the project Supply and Delivery of Books to New Century Books and General Merchandise.
